### MEMBERSHIP AND TERMS

INDIVIDUAL MEMBERSHIP: For a single Member. Dues are billed annually at the prevailing rate of \$350.

FAMILY MEMBERSHIP: For a Member and the immediate family, including spouse and children. Dues are billed annually at the prevailing membership rate of \$550.

MONTH-TO-MONTH MEMBERSHIP: For a single Member. Dues are billed monthly at \$50. Rate is locked for the first 12 months of Membership and may be subject to a rate increase for subsequent months.

### MEMBERSHIP PRIVILEGES:

- Unlimited use of the racquet sport facilities.
- Use of outdoor dining facilities, including the dining room patio. Food and drink purchases are additional.
- Full use of the changing rooms and restrooms near the pool. POOL USE IS NOT INCLUDED IN THE RACQUET MEMBERSHIP.
- Authorization to bring the same guest twice per month for a \$10 fee per visit. Management must be advised when bringing a guest.

### TERMS AND CONDITIONS OF MEMBERSHIP

1. I/We hereby agree to accept and abide by the terms of this Membership Agreement, including the Terms and Conditions of Membership in the agreement contract. I/We understand that this Membership Agreement is for

the initial term stated above and will continue for the term unless cancelled in accordance with the Terms and Conditions of the Membership.

2. **GENERAL.** The types of Racquet Membership available, applicable fees, suspension and expulsion of Members, and all other matters affecting the Members or Membership will be at the sole discretion of The Greencroft Club, Inc. It is the policy of The Greencroft Club, Inc., to accept applications for Membership from any individual, couple, or family of responsible credit background without regard to race, color, creed, gender, religion, or national origin, nor shall such matters ever be made a condition of Membership. Membership is nontransferable or assignable. The Member is responsible to notify the Club of any changes in address or phone number.
3. **ASSUMPTION OF RISK AND HEALTH.** Any Member, family members, and any guests that accompany a Member, warrants and represents that they are capable of engaging in active or passive exercise and do not suffer from any infirmity or disability that would render their participation in exercise harmful to their health or safety and/or the health and safety of any other Members. Members, family members, and guests agree to follow any and all health and safety instructions of The Greencroft Club, Inc., to prevent accidents and injuries.
4. Member, on behalf of him/herself and any members of the family part of a Membership, and any guests that accompany a Member, acknowledge that the use of the Club's facilities, equipment, services, and programs involves an inherent risk of personal injury. All Members and guests should be aware of their medical history and consult with a physician prior to engaging in or continuing exercise if a medical condition exists. **Member, family members, and guests assume all risks of personal injury to him/herself, his/her family members, and guests, and the waiver of liability and indemnification provisions set forth in paragraph 5 below are incorporated into this paragraph 4 as fully as if set forth herein verbatim.**
5. **WAIVER OF LIABILITY AND INDEMNIFICATION.** The Member hereby waives any claims of liability of whatsoever nature and releases The Greencroft Club, Inc., and its agents, representatives, employees, and Board Members for liability for claims of personal injury and property damage or loss incurred by the Member, his/her family member, or his/her guests at/on The Greencroft Club, Inc.'s facilities or sponsored events. Member agrees to indemnify and hold harmless The Greencroft Club, Inc., its agents, representatives, employees, and Board Members against and from any and all demands and claims, suits, actions, causes of action, and liabilities, including attorneys' fees, resulting from personal injury, property damage or loss, or any other damages of whatsoever nature caused directly or indirectly by the conduct of the Member, his/her family members, or guests of the Member, including without limitation the negligent, reckless, willful, and intentional conduct of any such person. For purposes of this waiver and indemnification provision, the Member shall be deemed to be the legal agent of his/her family members and guests with the authority to act on their behalf.
6. **TERMINATION/USAGE.** Each Racquet Member shall have the right to the use of the facilities, within the parameter of the Membership, and special programs of The Greencroft Club, Inc., Racquet Membership during the term of the agreement subject to provisions herein and any rules and regulations in force or hereafter established by The Greencroft Club, Inc., management. The Greencroft Club, Inc., reserves the right to terminate any Membership at any time for any violation of the By-laws and rules of The Greencroft Club, Inc., or any conduct which, in the opinion of management in its sole discretion, is detrimental to the welfare, good order, and character of the Club.
7. **ENTIRE AGREEMENT.** This agreement constitutes the entire Racquet Membership agreement between the parties. There have been no promises, warranties, or representations pertaining directly or indirectly to this agreement which are not contained herein. This agreement may be modified in writing when agreed to by both the Member and The Greencroft Club, Inc.
