MEMBERSHIP INFORMATION

Summer Membership

Available to individuals and families who wish to belong to Greencroft in the summer months only. The timeframe from approximately May 1st to September 26th will coincide with the opening and closing of the pool. The Membership will include the use of all outdoor dining facilities including the dining room patio. The Membership does not include use of the racquet courts or dining rooms. An upfront fee of \$1,000.00 for a family and \$800.00 for a single is due upon membership. Food charges are separate; no minimum monthly food purchase is required. At the end of the Summer Membership, should the Member join as a permanent member, \$250.00 of the original fee for a family and \$200 for a single will be credited toward the initiation fee.

Billing Policy

Each Member will receive a statement reflecting all charges made to the Member account for the previous month. Statements are processed and mailed during the first five working days of each month. Delinquent accounts are assessed a finance charge of 1.5% per month. After sixty days, all delinquent accounts will be posted in a conspicuous place in the Club. After ninety days, a notification will be sent to the Member account address by certified mail. If remittance is not made within ten days of notification, the Club will file for damages with Small Claims Court for collection. Any costs incurred as a result of such action will be the responsibility of the Member. A Member may not resign until all outstanding bills have been brought current.
